Graduation for Boating Students



ADVANCE NOTICE

9) VHF-DSC Test Calls

The Canadian Coast Guard national VHF-DSC (digital selective calling) network controlled by MCTS centres will soon process VHF-DSC "Test Calls" from vessels provided that the marine radio meets the International Telecommunications Union (ITU) standard Recommendation M.493-11 (or higher) "Digital selective-calling system for use in the maritime mobile service".

The Canadian Coast Guard VHF-DSC equipment will be configured to automatically acknowledge VHF-DSC test calls within seconds of receipt provided that the MCTS centre VHF-DSC equipment is not processing higher priority DSC calls.

Each MCTS centre will announce the availability of the VHF-DSC Test Call capability by the promulgation of a Notice to Shipping. *Thanks to Norm Dyck*

At the General Meeting tonight I informed the members about an application to develop a marina in Squirrel Cove. Anyone who has cruised in the Desolation Sound area will know that this is one of the most popular and secure anchorages in the area. Those present were sufficiently disturbed that they agreed that I should send the basic information to all the members for whom we have email addresses. I attach a file that has some notes put together by Bill Wilson, plus a short version of the management plan and a map of the proposed development showing the distribution of docks and mooring buoys.

This issue was also discussed at the Council of BC Yacht Clubs meeting on Saturday.. The Council is opposed to this application in its current form, although not to some form of marina and docks in the cove. The main problem is the fact that the proposed mooring buoys take up virtually all of the anchorage area in the cove.

The other concern of the Council, is that this may just be the tip of the iceberg and, if this is successful, other anchorages may be subject to similar applications.

We are asking that any members who feel strongly about this proposal write an email to Cameron Bezanson at the Integrated Land Management Bureau of the Provincial Government (contact information is given below).

- Many boaters use it for a few days at a time.
- No long term use
- Peaceful with minimal development on shore.
- It is a No-Discharge Zone
- Sometimes estimated to have 200 boats anchored
- Qathen Xwegus Management Corporation has applied to lease virtually the whole of Squirrel Cove (map included)
- To be known as Squirrel Cove Marine Resort (SCMR)
- Proposal includes a marina, 63 slips ranging from 45 to 83', and 320 one- or two-point mooring buoys
- Minimum Vessel length considered is 45', median or average, both are used, length is 50'
- Rates only shown for monthly moorage, includes per foot rate for buoys
- Area applied for is between 49.5 ha. 53.2 ha. depending on document
- Occupies approximately 95% of the cove with a water depth > 2 m.
- Management Plan notes issues with black water discharge, speeding, safety and inefficient, unsafe anchorage but there is no supporting documentation
- Council members at the June 11th meeting stated they had not encountered any of these issues while in Squirrel Cove
- Marina will have fuel dock, float plane and water taxi docks, shore power
- Will have marked navigation channels to be kept clear at all times
- Four area outside lease will be available for public anchoring (see map)
- One area, Anchorage 2, appears to small to be of any use
- Suggested capacity is 45-50 boats of average length of 50'
- Plan notes that only 7% of water surface would be covered at full capacity
- Anchorage will be permitted within open areas of lease at the direction of SCMR

Parks Canada has heard, through focus group research conducted in 2010 and through informal feedback, that boaters prefer to tie up for the night by 3 or 4pm. We have also heard that it is often difficult for overnight boaters to find mooring buoys within the park at that time causing many to have to seek alternate moorage locations or options.

This year, Parks Canada has changed the (free) day use mooring times at the Sidney Spit, Beaumont, and Cabbage/Tumbo buoys to better address overnight moorage needs. Starting immediately, day use mooring will end at 3 pm and overnight fees will be charged from 3pm on.
